EN010082 – THE TEES COMBINED CYCLE POWER PLANT PROJECT – APPLICANT'S DEADLINE 4 SUBMISSION PART 2 – NON-MATERIAL CHANGE CONSULTATION REPORT

THE PLANNING ACT 2008 (AS AMENDED) AND THE INFRASTRUCTURE PLANNING (EXAMINATION PROCEDURE) RULES 2010 (AS AMENDED) – RULE 17

I write on behalf of Sembcorp Utilities (UK) Limited (the 'Applicant') in respect of Deadline 4 of the examination (the 'Examination') into the Tees Combined Cycle Power Plant Project (the 'Project').

Following submission of the Non-Material Change Consultation Report (Application Document Ref: 8.40) on 29 June 2018 (Deadline 4 Submission– Part 1); enclosed with this letter is the remainder of the information submitted by the Applicant for Deadline 4 (Deadline 4 Submission – Part 2). The information was requested by the ExA at the recent Issue Specific Hearing ('ISH') on Environmental Matters and ISH on the draft Development Consent Order ('DCO') (held on 13 and 14 June 2018).

- Follow up items on Air Quality (Application Document Ref: 8.47) – submitted to address queries raised by the ExA at the ISH on Environmental Matters, including in respect of the locations of 'moderate' 1 hour NO₂ concentrations, sampling equipment for an 8 metre diameter stack and a preamble to the detailed Habitats Regulations Assessment data (see below);
- Detailed Habitats Regulations Assessment data (Excel file) (Application Document Ref: 8.48) – the data was not provided as part of the Application on the basis of its size, but was requested by the ExA (in Excel format) at the ISH on Environmental Matters;

- Updated Construction Environmental Management Plan (tracked and clean versions) – including all changes made since the original document was submitted, such as reference to BS5228 on construction noise and out of hours/emergency construction noise (Application Document Ref: 8.3.20); and
- Statement of Common Ground with Redcar and Cleveland Borough Council (Application Document Ref: 7.3) – signed and with all matters agreed.

In addition to the above, the Applicant wishes to provide an update in respect of other matters discussed at the recent ISHs, as follows:

- Statement of Common Ground with the Environment Agency (Application Document Ref: 7.4) – the Applicant issued an updated SoCG to the Environment Agency ('EA') following the ISH on Environmental Matters and then met with EA staff on 04 July 2017 to discuss the updated document. It was agreed that a number of matters can be moved to the 'matters agreed' section of the SoCG and that the EA will issue an updated version. It is proposed to submit an updated SoCG at Deadline 5 of the Examination;
- Carbon Capture Readiness ('CCR') – the Applicant has commissioned a technical report to further assess the ability to accommodate sufficient space within the Project Site and this is in the process of being verified by Imperial College London;
- Section 106 – the Applicant has drafted the document and will shortly issue to Redcar and Cleveland Borough Council for review; and
- Leases with National Grid – the document are still with National Grid's legal department and the Applicant has been advised that comments should be issued shortly.

I trust that this letter and enclosures provide the information required from the Applicant for Deadline 4.

I would be grateful if you could confirm receipt of this letter.
