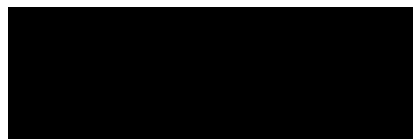
Update on other matters

- Section 106 – the Applicant has drafted the document and it has been sent to Redcar and Cleveland Borough Council for review; and
- Carbon Capture Readiness ('CCR') – the Applicant is in the process of discussing the latest technical feedback with the Environment Agency. Discussions had been progressing positively; however, due to resourcing issues at the Agency as a result of annual leave, it has not been possible to resolve the matter for Deadline 6. The Applicant proposes to provide an update at the earliest possible opportunity, as soon as further discussions have taken place and an agreement is hopefully reached with the Agency.
