Application by Net Zero Teesside Power Limited and Net Zero North Sea Storage Limited ("the Applicant") for an Order granting Development Consent for the proposed Net Zero Teesside project ("the proposed Development")

- Following the completion of the Examination on 10 November 2022, the Examining Authority submitted a Report and Recommendation in respect of its findings and conclusions on the application for the proposed Development (the "Application") to the Secretary of State on 10 February 2023. The statutory deadline for determining the Application is 10 May 2023.
- 2. The Secretary of State issued a letter requesting further information on 10 March 2023. The deadline for response was 24 March 2023.
- 3. The Secretary of State now invites the Applicant to comment on the responses to that letter, and requests that all parties listed in Annex A now respond. The responses received and 10 March 2023 letter are published on the Net Zero Teesside project page:
